

Email Registration Notice and Website Terms of Use

1. DESCRIPTION OF SERVICES

This Notification explains the terms and conditions that govern your receipt of services from the State of Michigan. The State of Michigan, through its contractors, provides this service used by law enforcement agencies to send you email alerts.
